### Customs: new Combined Nomenclature Explanatory Notes

The European Commission has published the new consolidated version of the Combined Nomenclature (CN) Explanatory Notes, in 23 languages. The CN Explanatory Notes contribute to the interpretation of the various tariff positions without, nevertheless, being legally binding. The latest version is now available in the EU Official Journal C 76 of 4 March 2015. ### Preparation for the future Union Customs Code

DG TAXUD is working towards finalising the adoption process for the Union Customs Code Delegated and Implementing Acts and will soon establish exchanges with Member States and professional organisations. Following this, the texts should then be formally adapted. For the Delegated Acts, final adoption of the texts and publication in the Official Journal should take place in July or September 2015. Concerning the Implementing Acts, the customs code committee is due to make an announcement in the second half of June, allowing for an adoption in July or September 2015.

The main issue for the Commission is to ensure the best possible transition between 1st May 2016 (the date on which the new Customs Code comes into force) and 31st December 2019, the deadline by which measures and IT services need to comply with the new norms. The Commission defines European standards which enable system interoperability.

### The customs publications in detail :

The customs publications include regulatory and conventional arrangements and as well as practical aspects for their application and interpretation.

- **Customs value:** value determination, evaluation methods, assessment bases for VAT and other taxes.
- **Origin:** definition, rules and justification of origin.
- **Customs clearance methods and procedures**

Common law: the customs declaration, authorised persons, guarantee rules, DELTA C procedure.

Simplified procedures: PDU (Single authorisation for clearance procedures), PDD (In-house customs clearance procedure), DELTA D and special procedures.

- **Transit:** the various transit procedures, the NCTS procedure, excluded goods, or subject to restrictions.
- **Procedures with economic impact:** storage, use, transformation.
- **Customs exemptions:** UNESCO exemption, personal goods, exemptions linked to the nature or the destination of the goods.
- **Trade tax regimes:** Import and Export VAT, Intra-community VAT, general arrangements for products subject to excise duty, parafiscal taxes.

- **Community customs code** and its implementation provisions. Regroups all the regulatory arrangements governing trade with third countries.

#### - French national customs code

Includes notably specific national legislation regarding litigations, energy, strategic or sensitive products for example.

In addition to the « Customs code » are the texts regulating financial relations with foreign companies, the decrees and orders pursuant to the national customs code.
